# **REPORT OF THE INSPECTORS OF ELECTION**

#### The Inspectors of Election, LLC (TIE)

## Amended and Restated CC&Rs and Bylaws Approval Vote

# Polls Open: Wednesday, May 22, 2019 Polls Close: Thursday, January 28, 2021

The Inspectors of Election, LLC (TIE) was contracted to serve as the oversight authority and independent, third party election service for Villa Avanti Association and were duly recognized by the Chair of the Board Meeting. (CA Corp. Code §7614.)

As the duly appointed Inspector of Election at the Board Meeting of Villa Avanti Association held on the date noted above and all adjournments thereto, we hereby report as follows:

## Membership Participation:

- 1. The total Membership is 474. The quorum requirement for an action by the Owners is more than 50% of the voting power; 238 lots if no voting rights are suspended.
- 2. TIE determined that a total of <u>323 members</u> (68.14%) were represented by ballot or present.
- No Registration Envelopes were received without signature that could not be counted towards quorum or opened and tabulated.

### **Supervision of Election**

- 1. TIE reviewed and supervised the registration process.
- 2. TIE determined the authenticity, validity, and effect of each of each ballot received prior to the close of the polls.
- 3. TIE determined all challenges and questions in any way arising in connection with the right to vote.
- 4. TIE determined if any ballots were invalid and were not counted for any reason.

## **Voting Process**

- 1. There were two (2) Measures up for vote to the membership:
  - a. Action 1: Approve the 2019 Amended and Restated CC&Rs.
  - b. Action 2: Approve the 2019 Amended and Restated Bylaws.
- 2. To Approve the 2019 Restated CC&Rs, Owners representing not less than sixty-seven percent (67%) of the voting power must vote for approval. If no voting rights are suspended, approval from the Owners of 318 lots is needed.
- 3. To Approve the 2019 Restated Bylaws, Owners representing not less than a majority of the voting power must vote for approval. If no voting rights are suspended, approval from the Owners of 238 lots is needed.
- 4. The votes for each action were as follows.
